

#### **H** Courses

H classification is given to a year 11 and 12 course which is designed and accredited by the Board of Senior Secondary Studies (BSSS) and an Australian university, and where successful completion of the course will be recognised both towards the ACT Senior Secondary Certificate and an undergraduate degree with that university.

The BSSS considers H courses as complementary to studies in the home college. These extension courses allow students to pursue depth of study in an area of interest, while also gaining experience in a tertiary context to prepare for future studies.

# The ACT Senior Secondary System

The ACT senior secondary system recognises a range of university, vocational or life skills pathways.

The system is based on the premise that teachers are experts in their area: they know their students and community and are thus best placed to develop curriculum and assess students according to their needs and interests. Students have ownership of their learning and are respected as young adults who have a voice.

A defining feature of the system is school-based curriculum and continuous assessment. School-based curriculum provides flexibility for teachers to address students' needs and interests. College teachers have an opportunity to develop courses for implementation across ACT schools. Based on the courses that have been accredited by the BSSS, college teachers are responsible for developing programs of learning. A program of learning is developed by individual colleges to implement the courses and units they are delivering.

Teachers must deliver all content descriptions; however, they do have flexibility to emphasise some content descriptions over others. It is at the discretion of the teacher to select the texts or materials to demonstrate the content descriptions. Teachers can choose to deliver course units in any order and teach additional (not listed) content provided it meets the specific unit goals.

School-based continuous assessment means that students are continually assessed throughout years 11 and 12, with both years contributing equally to senior secondary certification. Teachers and students are positioned to have ownership of senior secondary assessment. The system allows teachers to learn from each other and to refine their judgement and develop expertise.

Senior secondary teachers have the flexibility to assess students in a variety of ways. For example: multimedia presentation, inquiry-based project, test, essay, performance and/or practical demonstration may all have their place. College teachers are responsible for developing assessment instruments with task specific rubrics and providing feedback to students.

The integrity of the ACT Senior Secondary Certificate is upheld by a robust, collaborative, and rigorous structured consensus-based peer reviewed moderation process. System moderation involves all year 11 and 12 teachers from public, non-government and international colleges delivering the ACT Senior Secondary Certificate.

Only students who desire a pathway to university are required to sit a general aptitude test, referred to as the ACT Scaling Test (AST), which moderates student scores across courses and colleges. Students are required to use critical and creative thinking skills across a range of disciplines to solve problems. They are also required to interpret a stimulus and write an extended response.

Senior secondary curriculum makes provision for student-centred teaching approaches, integrated and project-based learning inquiry, formative assessment, and teacher autonomy. ACT Senior Secondary Curriculum makes provision for diverse learners and students with mild to moderate intellectual disabilities, so that all students can achieve an ACT Senior Secondary Certificate.

The ACT Board of Senior Secondary Studies (BSSS) leads senior secondary education. It is responsible for quality assurance in senior secondary curriculum, assessment, and certification. The Board consists of nominees from colleges, professional bodies, universities, industry, parent/carer organisations and unions. The Office of the Board of Senior Secondary Studies (OBSSS) consists of professional and administrative staff who support the Board in achieving its objectives and functions.

# **ACT Senior Secondary Certificate**

Courses of study for the ACT Senior Secondary Certificate:


- provide a variety of pathways, to meet different learning needs and encourage students to complete their secondary education
- enable students to develop the essential capabilities for twenty-first century learners
- empower students as active participants in their own learning
- engage students in contemporary issues relevant to their lives
- foster students' intellectual, social, and ethical development
- nurture students' wellbeing, and physical and spiritual development
- enable effective and respectful participation in a diverse society.

#### Each course of study:

- comprises an integrated and interconnected set of knowledge, skills, behaviours, and dispositions that students develop and use in their learning across the curriculum
- is based on a model of learning that integrates intended student outcomes, pedagogy, and assessment
- outlines teaching strategies which are grounded in learning principles and encompass quality teaching
- promotes intellectual quality, establish a rich learning environment, and generate relevant connections between learning and life experiences
- provides formal assessment and certification of students' achievements.

## **Underpinning beliefs**

- All students are able to learn.
- Learning is a partnership between students and teachers.
- Teachers are responsible for advancing student learning.



# **Learning Principles**

- 1. Learning builds on existing knowledge, understandings, and skills. (*Prior knowledge*)
- 2. When learning is organised around major concepts, principles, and significant real-world issues, within and across disciplines, it helps students make connections and build knowledge structures. (Deep knowledge and connectedness)
- Learning is facilitated when students actively monitor their own learning and consciously develop ways of organising and applying knowledge within and across contexts. (Metacognition)
- Learners' sense of self and motivation to learn affects learning. (Self-concept)
- 5. Learning needs to take place in a context of high expectations. (High expectations)
- 6. Learners learn in different ways and at different rates. (Individual differences)
- 7. Different cultural environments, including the use of language, shape learners' understandings and the way they learn.
  - (Socio-cultural effects)
- 8. Learning is a social and collaborative function as well as an individual one. *(Collaborative learning)*
- Learning is strengthened when learning outcomes and criteria for judging learning are made explicit and when students receive frequent feedback on their progress. (Explicit expectations and feedback)

# **General Capabilities**

All courses of study for the ACT Senior Secondary Certificate should enable students to develop essential capabilities for twenty-first century learners. These 'capabilities' comprise an integrated and interconnected set of knowledge, skills, behaviours and dispositions that students develop and use in their learning across the curriculum.

The capabilities include:

- literacy
- numeracy
- information and communication technology (ICT)
- · critical and creative thinking
- personal and social
- ethical understanding
- · intercultural understanding

Courses of study for the ACT Senior Secondary Certificate should be both relevant to the lives of students and incorporate the contemporary issues they face. Hence, courses address the following three priorities. These priorities are:

- Aboriginal and Torres Strait Islander histories and cultures
- Asia and Australia's engagement with Asia
- Sustainability

#### Literacy

In UC H Course Understanding People and Behaviour, students become literate as they develop the knowledge, skills and dispositions to interpret and use language confidently for listening, engaging in collaborate practice, and expressing scientific research and conclusions about questions and problems in Psychology and consider how that translates into practical applications. Literacy in UC H Course Understanding People and Behaviour involves students listening to, reading, viewing, speaking, writing, and creating academic texts, and using and modifying language for different purposes in an academic university context.

#### Numeracy

In UC H Course Understanding People and Behaviour, students become numerate as they develop the knowledge and skills to understand a range of statistical techniques used in scientific research that will allow them to interpret data in order to communicate the findings from psychological experiments and studies. Numeracy in UC H Course Understanding People and Behaviour encompasses the knowledge and skills students need to use in a wide range of situations. It involves students recognising and understanding the role of statistical methods in the world and having the capacities to understand scientific research methods and skills purposefully.

#### Information and Communication Technology (ICT) Capability

In UC H Course Understanding People and Behaviour students develop Information and Communication Technology (ICT) capability as, in examining psychological issues, they learn to use ICT effectively and appropriately to access, create and communicate information and ideas, solve problems and work collaboratively. They consider the role and culpability of ICT in creating and in addressing a range of psychological and mental health challenges and opportunities. ICT capability involves students learning to make the most of the digital technologies available to them, adapting to new ways of studying and being, as technologies evolve and understanding the risks to themselves and others in a digital environment.

#### **Critical and Creative Thinking**

In UC H Course Understanding People and Behaviour, students develop capability in critical and creative thinking as they learn to generate and evaluate knowledge, clarify concepts and ideas, seek possibilities, consider alternatives, and solve problems in Psychology. They engage in thinking critically about issues in Psychology and the ways different theories highlight and obscure different questions and opportunities. They think creatively about solutions to challenges to individuals, groups and to the community. Critical and creative thinking involves students thinking broadly and deeply using skills, behaviours, and dispositions such as reason, logic, resourcefulness, imagination, and innovation.

#### **Personal and Social Capability**

In UC H Course Understanding People and Behaviour, students develop personal and social capability as they learn to understand themselves and others, and manage their relationships, lives, work and learning more effectively by examining and accounting for human psychology and the needs and practices of communities and individuals worldwide. They develop the skills to engage in respectful and thoughtful discussion and investigation of significant and controversial issues. As they investigate questions in Psychology, they build personal and social capability through a range of practices including recognising and regulating emotions, developing empathy for others and understanding relationships, establishing and building positive relationships, making responsible decisions, working effectively in teams, handling challenging situations constructively and developing leadership skills. These will be further developed by learning top operate and learn in the university context.

#### **Ethical Understanding**

In UC H Course Understanding People and Behaviour, students develop ethical understanding, as they identify and investigate the nature of ethical concepts and values and understand how reasoning can assist ethical judgement. Further, they problematise ethical knowledge by examining how ethics affects the generation of knowledge in Psychology. Ethical understanding involves students building a strong personal and socially oriented ethical outlook that helps them to manage context, conflict and uncertainty, and to develop an awareness of the influence that their values and behaviour have on others through the exploration of their ethics as researchers and thinkers.

#### **Intercultural Understanding**

In UC H Course Understanding People and Behaviour, students develop intercultural understanding as they learn to value their own cultures, languages, and beliefs, and those of others. They come to understand how personal, group and national identities are shaped, and the variable and changing nature of culture. Intercultural understanding involves students learning about and engaging with diverse cultures in ways that recognise commonalities and differences, create connections with others and cultivate mutual respect.

### **Cross Curriculum Priorities**

#### **Aboriginal and Torres Strait Islander Histories and Cultures**

The Aboriginal and Torres Strait Islander histories and cultures priority provides the opportunity for all young Australians to gain a deeper understanding and appreciation of Aboriginal and Torres Strait Islander histories and cultures, deep knowledge traditions and holistic world views. This knowledge and understanding provided in UC H Course Understanding People and Behaviour will enrich all learners' ability to participate positively in the ongoing development of Australia through a deepening knowledge and connection with the world's oldest continuous living cultures.

#### Asia and Australia's Engagement with Asia

This priority in UC H Course Understanding People and Behaviour will ensure that students learn about and recognise the diversity within and between the countries of the Asia region. They will develop knowledge and understanding of Asian societies, cultures, beliefs, and environments. Asia literacy provides students with the skills to communicate and engage with the peoples of Asia so they can effectively live, work and learn in the region.

#### Sustainability

The sustainability priority provides the opportunity for students to develop an appreciation of the necessity of acting for a more sustainable future and so address the ongoing capacity of Earth to maintain all life and meet the needs of the present without compromising the needs of future generations. UC H Course Understanding People and Behaviour will allow students to examine connections between human psychology and their experience of their environment.

# UC H Course Understanding People and Behaviour

#### Rationale

Understanding People and Behaviour is a first-year university study program that introduces students to the science and research underpinning the discipline of applied psychology. In this course, students analyse and unpack psychological research to understand why people think and behave as they do across a selection of common real-world situations.

Students will develop social, academic, and work skills as they engage with UC academics and students from across the territory. They will acquire skills in face to face and online collaboration in developing and completing projects. Students will develop project skills and hone and refine their capacity to investigate, research and critically analyse data in Psychology.

H courses provide an enriching means of transitioning from the secondary to the tertiary environment, as students will have opportunities to develop dispositions, work habits and experiences that will create a foundation for tertiary study.

#### Goals

- sense of wonder and curiosity about nature and an appreciation of how scientific knowledge can be used to address contemporary issues
- understanding of the theories and models used to describe, explain, and make predictions about systems, structures, and properties to provide a reliable basis for action
- understanding that scientific knowledge is developing over time, is being used in a variety of
  contexts; and influences, and is continuing to be influenced by, historical, social, economic,
  cultural and ethical considerations and new discoveries understanding that Science is
  experimental and has developed through independent and collaborative research, and has
  significant impacts on society and implications for decision making
- ability to design and conduct a variety of field and laboratory investigations involving collection and critical analysis of data, and interpretation of evidence
- ability to critically evaluate scientific concepts, interpretations, and claims in order to solve problems and generate informed, considered, and ethical conclusions
- ability to communicate scientific understanding, findings, arguments, and conclusions using appropriate representations, modes, and genres.

# **Organisation of Content**

#### The Science of Human Behaviour

In this first-year equivalent unit, students will be introduced to the methods psychologists use in their research, the science of psychological measurement and learn how to make sense of, unpack and summarise psychological research articles in a structured and systematic way. Students will be introduced to a selected range of psychological ideas and concepts and will work through how the evidence based was developed from the seminal ideas and papers to a critical look at modern-day research. The psychological ideas covered will be in the form of questions. For example, (1) Is there evidence to support the idea that money can make you happy; (2) Is there evidence to support the idea that grievances develop from breaches of social contracts and our own expectations; and (4) Is there evidence to guide us in understanding how people flourish.

#### **Understanding People, Behaviour and Change**

In this first-year equivalent unit, students investigate a range of theories that explain how people change their behaviour, what happens when people work in teams and why team working relationships and team decisions may not always work well, how people make sense of the behaviour of others, why we judge people, how can people manage their stress effectively, what are the most common forms of psychological disorders and how are they managed. After exploring the research, you will be assisted to apply theory to understand what is occurring in a range of real-world problems and then use scientific evidence to provide workable solutions.

### **Assessment**

The identification of criteria within the achievement standards and assessment tasks types and weightings provide a common and agreed basis for the collection of evidence of student achievement.

**Assessment Criteria** (the dimensions of quality that teachers look for in evaluating student work) provide a common and agreed basis for judgement of performance against unit and course goals, within and across colleges. Over a course, teachers must use all these criteria to assess students' performance but are not required to use all criteria on each task. Assessment criteria are to be used holistically on a given task and in determining the unit grade.

**Assessment Tasks** elicit responses that demonstrate the degree to which students have achieved the goals of a unit based on the assessment criteria. The Common Curriculum Elements (CCE) is a guide to developing assessment tasks that promote a range of thinking skills (see Appendix C). It is highly desirable that assessment tasks engage students in demonstrating higher order thinking.

**Rubrics** are constructed for individual tasks, informing the assessment criteria relevant for a particular task, and can be used to assess a continuum that indicates levels of student performance against each criterion.

#### **Assessment Criteria**

Students will be assessed on the degree to which they demonstrate understanding of:

- concepts, models, and application
- contexts
- inquiry skills.

### **Assessment Task Types**

#### Suggested tasks

Individual tasks may incorporate one or more of the following:

- models
- commentary
- debate
- portfolio/journal
- field work
- investigation
- document/source analysis
- practical report
- role play
- research report
- test/quiz

- seminar/workshop/lecture
- poster
- response to stimulus
- essay
- multimedia presentation
- creative response
- interview
- discussion forum
- rationale/validation
- practical skills

It is recommended that a student conceived investigation be undertaken at least once during a minor and twice during a major. This investigation may either be theoretical or practical, or a combination of both.

#### Weightings in T 1.0:

No task to be weighted more than 45% for a standard 1.0 unit.

#### Additional Assessment Information

- For a standard unit (1.0), students must complete a minimum of three assessment tasks and a maximum of five.
- Students must experience a variety of task types and different modes of communication to demonstrate the Achievement Standards in both theoretical and practical tasks.
- All Achievement Standards must be demonstrated in a standard (1.0) unit.
- Task types need to be selected to address all Achievement Standards within the Concepts, Models and Applications, Contexts, and Inquiry Skills strands across a standard unit.
- For tasks completed in unsupervised conditions, schools need to have mechanisms to uphold academic integrity, for example: student declaration, plagiarism software, oral defence, interview, or other validation tasks.

# **Achievement Standards**

A Year 12 student in any unit is assessed using the Year 12 achievement standards. A Year 11 student in any unit is assessed using the Year 11 achievement standards. Year 12 achievement standards reflect higher expectations of student achievement compared to the Year 11 achievement standards. Years 11 and 12 achievement standards are differentiated by cognitive demand, the number of dimensions and the depth of inquiry.

An achievement standard cannot be used as a rubric for an individual assessment task. Assessment is the responsibility of the college. Student tasks may be assessed using rubrics or marking schemes devised by the college. A teacher may use the achievement standards to inform development of rubrics. The verbs used in achievement standards may be reflected in the rubric. In the context of combined Years 11 and 12 classes, it is best practice to have a distinct rubric for Years 11 and 12. These rubrics should be available for students prior to completion of an assessment task so that success criteria are clear.

#### The Science of Human Behaviour

#### **Unit Description**

In this first-year equivalent unit, students will be introduced to the methods psychologists use in their research, the science of psychological measurement and learn how to make sense of, unpack and summarise psychological research articles in a structured and systematic way. Students will be introduced to a selected range of psychological ideas and concepts and will work through how the evidence based was developed from the seminal ideas and papers to a critical look at modern-day research. The psychological ideas covered will be in the form of questions. For example, (1) Is there evidence to support the idea that money can make you happy; (2) Is there evidence to support the idea that grievances develop from breaches of social contracts and our own expectations; and (4) Is there evidence to guide us in understanding how people flourish.

- understand the methods used in seminal and contemporary research to understand to a university standard how theories are developed and evolve through evidence
- understand to a university standard the most common experimental designs in psychology, and an introduction to the types of statistical techniques used in research

#### **Concepts, Models and Applications**

# Understanding People, Behaviour and Change

# **Unit Description**

In this first-year equivalent unit, students investigate a range of theories that explain how people change their behaviour, what happens when people work in teams and why team working relationships and team decisions may not always work well, how people make sense of the behaviour of others, why we judge people, how can people manage their stress effectively, what are the most common forms of psychological disorders and how are they managed. After exploring the research, you will be assisted to apply theory to understand what is occurring in a range of real-world problems and then use scientific evidence to provide workable solutions.

# **Specific Unit Goals**

This unit should enable students to:

- understand research into social behaviour, psychological disorders, and their management, to a university standard
- understand the evidence base to support behaviour change programs to a university standard
- use psychological methods and theories to crucially analyse real-world problems and propose evidence-based solutions to a university standard

## **Content Descriptions**

All knowledge, understanding and skills below must be delivered:

#### **Concepts, Models and Applications**

- critically analyse a set of real-life case studies in order to identify the most relevant
  psychological theories to draw conclusions about what is occurring, e.g. in cases where

# Appendix A – Implementation Guidelines

#### **Available course patterns**

A standard 1.0 value unit is delivered over at least 55 hours. To be awarded a course, students must complete at least the minimum units over the whole minor, major, major/minor, or double major course.

Course	Number of standard units to meet course requirements
Minor	Minimum of 2 units

Units in this course can be delivered in any order.

#### Prerequisites for the course or units within the course

Students must be enrolled in BSSS Psychology or Sociology in their home college to be eligible for this H Course.

## **Duplication of Content Rules**

Students cannot be given credit towards the requirements for a Senior Secondary Certificate for a unit that significantly duplicates content in a unit studied in another course. The responsibility for preventing undesirable overlap of content studied by a student rests with the principal and the teacher delivering the course. Students will only be given credit for covering the content once.

# **Guidelines for Delivery**

#### **Program of Learning**

A program of learning is what a school provides to implement the course for a subject. This meets the requirements for context, scope and sequence set out in the Board endorsed course. Students follow programs of learning in a college as part of their senior secondary studies. The detail, design, and layout of a program of learning are a college decision.

The program of learning must be documented to show the planned learning activities and experiences that meet the needs of particular groups of students, taking into account their interests, prior knowledge, abilities, and backgrounds. The program of learning is a record of the learning experiences that enable students to achieve the knowledge, understanding and skills of the content descriptions. There is no requirement to submit a program of learning to the OBSSS for approval. The Principal will need to sign off at the end of Year 12 that courses have been delivered as accredited.

#### **Content Descriptions**

Are all content descriptions of equal importance? No. It depends on the focus of study. Teachers can customise their program of learning to meet their own students' needs, adding additional content descriptions if desired or emphasising some over others. A teacher must balance student needs with their responsibility to teach all content descriptions. It is mandatory that teachers address all content descriptions and that students engage with all content descriptions.

#### Moderation

Moderation is a system designed and implemented to:

- provide comparability in the system of school-based assessment
- form the basis for valid and reliable assessment in senior secondary schools
- involve the ACT Board of Senior Secondary Studies and colleges in cooperation and partnership
- maintain the quality of school-based assessment and the credibility, validity, and acceptability of Board certificates.

Moderation commences within individual colleges. Teachers develop assessment programs and instruments, apply assessment criteria, and allocate Unit Grades, according to the relevant Framework. Teachers within course teaching groups conduct consensus discussions to moderate marking or grading of individual assessment instruments and unit grade decisions.

#### **The Moderation Model**

Moderation within the ACT encompasses structured, consensus-based peer review of Unit Grades for all accredited courses, as well as statistical moderation of course scores, including small group procedures, for T courses.

#### Moderation by Structured, Consensus-based Peer Review

Review is a subcategory of moderation, comprising the review of standards and the validation of Unit Grades. In the review process, Unit Grades, determined for Year 11 and Year 12 student assessment portfolios that have been assessed in schools by teachers under accredited courses, are moderated by peer review against system wide criteria and standards. This is done by matching student performance with the criteria and standards outlined in the unit grade descriptors as stated in the Framework. Advice is then given to colleges to assist teachers with, and/or reassure them on, their judgments.

#### Preparation for Structured, Consensus-based Peer Review

Each year, teachers teaching a Year 11 class are asked to retain originals or copies of student work completed in Semester 2. Similarly, teachers teaching a Year 12 class should retain originals or copies of student work completed in Semester 1. Assessment and other documentation required by the Office of the Board of Senior Secondary Studies should also be kept. Year 11 work from Semester 2 of the previous year is presented for review at Moderation Day 1 in March, and Year 12 work from Semester 1 is presented for review at Moderation Day 2 in August.

In the lead up to Moderation Day, a College Course Presentation (comprised of a document folder and a set of student portfolios) is prepared for each A, T and M course/units offered by the school and is sent into the Office of the Board of Senior Secondary Studies.

#### The College Course Presentation

The package of materials (College Course Presentation) presented by a college for review on moderation days in each course area will comprise the following:

- a folder containing supporting documentation as requested by the Office of the Board through memoranda to colleges
- a set of student portfolios containing marked and/or graded written and non-written assessment responses and completed criteria and standards feedback forms. Evidence of all assessment responses on which the unit grade decision has been made is to be included in the student review portfolios.

Specific requirements for subject areas and types of evidence to be presented for each Moderation Day will be outlined by the Board Secretariat through memoranda and Information Papers.

# Visual evidence for judgements made about practical performances

#### (also refer to BSSS Website Guidelines)

It is a requirement that schools' judgements of standards to practical performances (A/T/M) be supported by visual evidence (still photos or video).

The photographic evidence submitted must be drawn from practical skills performed as part of the assessment process.

# Appendix E – Glossary for ACT Senior Secondary Curriculum

Courses will detail what teachers are expected to teach and students are expected to learn for year 11 and 12. They will describe the knowledge, understanding and skills that students will be expected to develop for each learning area across the years of schooling.

**Learning areas** are broad areas of the curriculum, including English, mathematics, science, the arts, languages, health, and physical education.

A **subject** is a discrete area of study that is part of a learning area. There may be one or more subjects in a single learning area.

**Frameworks** are system documents for Years 11 and 12 which provide the basis for the development and accreditation of any course within a designated learning area. In addition, frameworks provide a common basis for assessment, moderation and reporting of student outcomes in courses based on the framework.

The **course** sets out the requirements for the implementation of a subject. Key elements of a course include the rationale, goals, content descriptions, assessment, and achievement standards as designated by the framework.

BSSS courses will be organised into units. A unit is a distinct focus of study within a course. A standard 1.0 unit is delivered for a minimum of 55 hours generally over one semester.

**Core** units are foundational units that provide students with the breadth of the subject.

**Additional** units are avenues of learning that cannot be provided for within the four core 1.0 standard units by an adjustment to the program of learning.

A **negotiated study unit** makes provision for students, classes, groups, or individuals to negotiate the program of learning based on the specific unit goals, content descriptions, assessment, and achievement standards of the course.

An **elective** is a lens for demonstrating the content descriptions within a standard 1.0 or half standard 0.5 unit.

A lens is a particular focus or viewpoint within a broader study.

**Content descriptions** refer to the subject-based knowledge, understanding and skills to be taught and learned.

A **program of learning** is what a college develops to implement the course for a subject and to ensure that the content descriptions are taught and learned.

**Achievement standards** provide an indication of typical performance at five different levels (corresponding to grades A to E) following completion of study of senior secondary course content for units in a subject.

ACT senior secondary system curriculum comprises all BSSS approved courses of study.
